## FEBS, the Federation of European Biochemical Societies

Founded on 1st January 1964, the Federation of European Biochemical Societies (FEBS) has become one of Europe's largest organizations in the molecular life sciences. It has over 30,000 members across 39 biochemistry and molecular biology societies (its 'Constituent Societies') in different countries of Europe and neighbouring regions. As a grassroots organization FEBS thereby provides a voice to a large part of the academic research and teaching community in Europe and beyond.

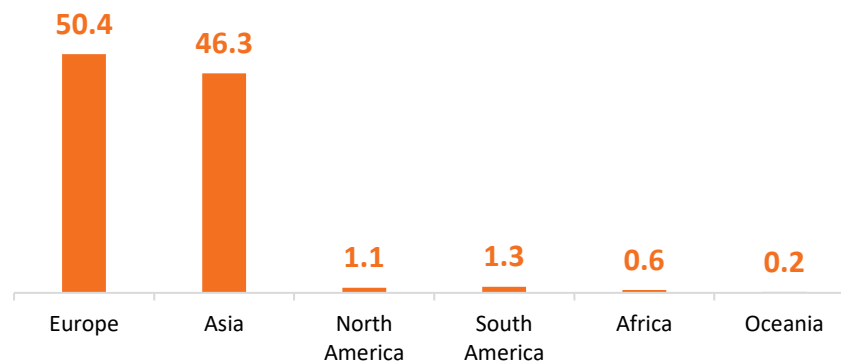

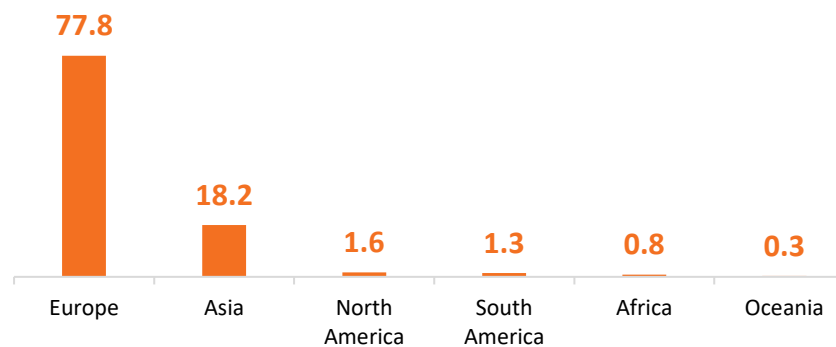

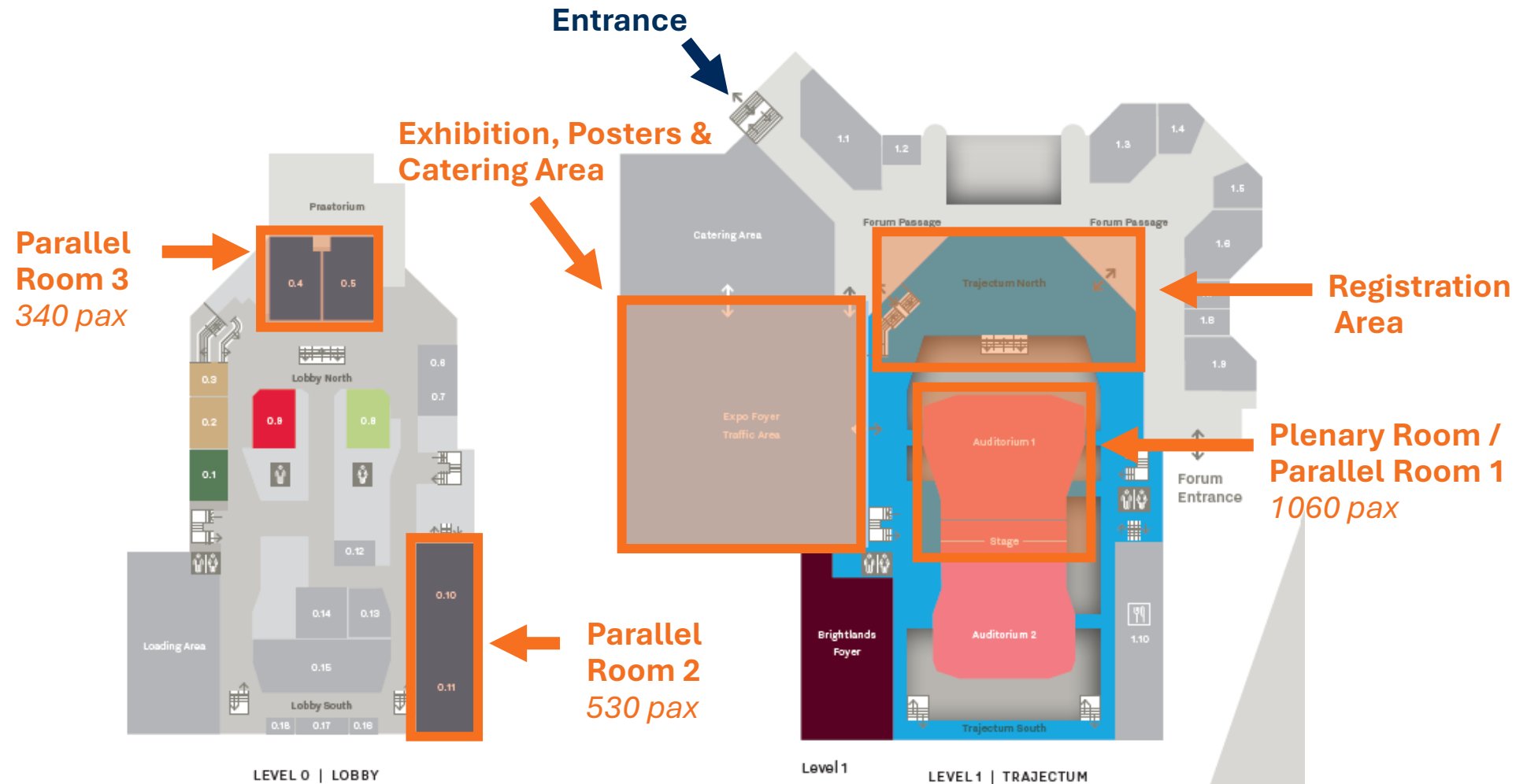

## Exhibition Layout

The exhibition floorplan will be available by September 2025. Spaces will be allocated on a 1st come-1st served basis depending on when your order is received by MCI Suisse SA.

## Exhibitor Registration

All exhibitors must be registered and will receive a badge displaying the exhibiting company name. A number of complimentary exhibitor badges are given based on the number of square meters booked. Additional exhibitors will be charged an exhibitor registration fee.

## Manning of Stands

Exhibitors will be required to ensure that their stands are manned during the opening hours of the exhibition and must not dismantle their stands before the published closing time.

## Noise

Exhibitors may not use audible electronic, mechanical apparatus, or open audio systems which may be heard outside the exhibitor's assigned space. The Organisers reserve the right to require any exhibitor to discontinue any activity that may cause annoyance or interference with others.

## Give-aways and Distribution of Printed Materials

No such material may be distributed in any hotel used by the meeting. Product identification is permitted on give-aways.
